CONTRACT: I understand that Leadership Grand Strand is a nine-month instructional program demanding my attendance <u>at not less than 7 sessions to qualify for graduation</u> . Session days are normally the first Thursday of each month and last from 8 a.m5 p.m. <u>Required sessions will be an orientation on Thursday, August 18, 2021, an out-of-town overnight retreat in September and the final session on Thursday, May 5, 2022. If selected to participate in the program, I agree to make all reasonable efforts to fulfill the requirements for graduation. I understand that I will be responsible for participating in 75 hours of community service involvement during the LGS experience.</u>
